### LETTER OF AGREEMENT

3. If you choose to cancel a registrant:
  - 3 weeks prior to the start of a Series, there will be no cancellation charge.
  - Less than 3 weeks of the Series start date, there will be a \$100 cancellation charge.
  - If a cancellation occurs within the 5 months of class **without** notification to **Envision Greater Fond du Lac, Inc.**, full monthly tuition charges will be billed until we receive notification from the participant's supervisor.
